Investing in the UK

The UK offers world-leading maritime services and expertise. London retains a leading position in the **Xinhua-Baltic International Shipping Centre Development Index Report.**

The UK is recognised for having:

- an internationally respected legal framework
- a highly skilled workforce

- English as its official language
- good links to the City of London

First for Law

London is first in the shipping services section, for law, arbitration, financing, insurance and brokerage services.

Technology and Innovation

The UK is taking a leading role in maritime technology innovation, including creating research and development centres and a regulatory framework for autonomous vessels.

Many investment and asset management firms, specialising in maritime, have their headquarters in the UK. These firms offer a wealth of opportunities for investors looking for real assets which provide diversification and links to the energy transition.

Safety and Security A global leader in maritime safety and security, the UK collaborates and builds alliances to ensure the security of shipping lanes and ports.

If you're considering where to base, where to flag, where to find worldleading professional services or where to get help in achieving your zero emission ambitions, the UK is the place to be.

Educational Programmes

With internationally recognised universities and academic providers, the UK delivers comprehensive educational programmes in various maritime disciplines, including law, research and sea-going roles.

Training facilities for shore employees and seafarers are conveniently located with easy access to transport hubs and are run by experienced practitioners.

Asset Management

Tonnage Tax

The UK's Tonnage Tax is a competitive alternative method of calculating Corporation Tax profits. It refers to the net tonnage of the ship operated. Profit replaces both the tax-adjusted commercial profit or loss on a shipping trade and the chargeable gains or losses made on Tonnage Tax assets. Other profits of a Tonnage Tax company are taxable in the normal way.

Companies within Corporation Tax, which operate qualifying ships that are "strategically and commercially managed in the UK", can take advantage of the Tonnage Tax.

Since its introduction in 2000, Tonnage Tax has encouraged many owners and operators to relocate to the UK.

New Election Window

For the first time since 2005, the UK government has opened an election window to allow shipping companies to enter UK Tonnage Tax. Opened June 2023, the election window will last for 18 months, closing November 2024.

Any qualifying companies who previously chose not to join Tonnage Tax, or who entered but subsequently left, can now join for a minimum of 8 years.

The election window allows companies to benefit from the reforms announced at Autumn Budget 2021, which include:

- removing the EU/EEA flag requirement
- reducing the lock-in period from 10 to 8 years
- increasing the permitted limit for "qualifying secondary income"

SMaRT Funding

Support for Maritime Training (SMarT) is a government funded scheme to increase the number of qualified seafarers in the UK maritime industry.

Eligible cadets receive 50% subsidy of the associated training costs. Eligible cadets must be enrolled on a course at a Maritime and Coastguard Agency (MCA) approved nautical college for an MCA approved academic qualification of level 4, or above.

A full list of cadet requirements and information about the application process can be found in MGN 455 and MIN 678.

Enhancements

In the Spring Budget 2023, the UK government announced further Tonnage Tax enhancements, effective from April 2024:

- raising capital allowance limit for ship lessors who lease into Tonnage Tax, to £200m
- allowance of third-party ship management

Maritime Professional Business Services

Freeports

UK Freeports are special areas within UK borders where different economic regulations apply. They bring together industry, government and educational institutions, enabling collaboration within a supportive environment to develop and trial new ideas and technologies.

Freeports offer:

- Stamp Duty Land Tax relief
- enhanced capital allowances for investment in plant and machinery, and structures and buildings
- business rates relief
- employer National Insurance contributions relief
- deferrals and exemptions from import duties
- supportive local planning environments with constructive public-private partnerships
- public investment in skills and infrastructure
- wide-ranging support from national and local government

Freeports encourage businesses from around the world to join new hubs of global trade that create job opportunities and boost the economic prospects of local communities.

Top Quality Education

The UK has long been a world class destination for training and education for students from around the world. Maritime courses provide seafarers with the training and experience they need to achieve certificates of competency, allowing the safe operation. maintenance, and navigation of vessels.

The UK also provides a range of revalidations and short courses to maintain skills, and to advance specialisations in vessel types or with certain equipment, ensuring every need is catered for.

Computer Based Training

UK maritime training continues to lead the way in innovation and new technology, with computer based training introduced to meet the everchanging needs of industry, and significant investment in areas such as virtual reality and performance management of crews.

The UK leads the way in ensuring that qualified mariners can embrace new roles and opportunities, and, when it's time to move ashore, the UK can support that too.

Green Growth including

£1 billion dedicated to the research, development and innovation needed to achieve net zero. This includes a £206 million fund for maritime decarbonisation innovation through the UK Shipping Office for Reducing Emissions (UKSHORE).

The UK's progressive regulatory climate encourages innovation and supports companies with projects both afloat and shoreside. The UK has committed to building an innovative, green economy, and is delivering this through projects such as the National Hydrogen Strategy and the Science and Technology Framework.

There is also a broad range of maritime expertise in London, which supports and engages with the International Maritime Organization's work.

Those registered to the UK Flag can access world-class surveyors and regulation through the Maritime and Coastguard Agency (MCA). The Red Ensign is a recognised flag around the world for the delivering high standards of maritime safety and the welfare of seafarers. UK Ship Register customers receive greater asset assurance and access to the world-leading industry experts.
